

Terms of Participation

- 1) The POWERBOAT WEEKEND / Poker-Run is an organized event. The event serves the purpose of entertainment and is not a motor boat race.
- 2) Only boats with a hull length of at least 24 feet may participate. The boat must be registered and in a traffic state. The Organizer reserves the right to refuse participation if he considers that the participating boat is not in a traffic state.
- 3) Participation takes place at your own risk. The organizer is not liable for damages to the boats, persons or other objects caused by a boat leader or a guest of a boatman to a third party. The participant shall indemnify the organizer and its assistants and agents from any liability.
- 4) Each participating boat or crew has their own boat liability insurance. This must be valid at the time of the event so that the insurance cover is guaranteed.
- 5) Each captain must have a valid driving license and boat registration for the respective area. Every participant has to bring this license and authorization with him. If the responsible boat leader*captain* is not in possession of a valid driving license and admission, he is excluded from participation. There is, however, no claim for repayment of the participation fee.
- 6) When participating in the Poker Run, each boat leader and passenger / captain and crew must comply with the prescribed regulations as well as the traffic, as well as to observe the traffic rules and to avoid conspicuous, disturbing or wanton acts. At the Poker Run station, harbors, fuel stations and all other collecting points of the route is to avoid suction and wave impact. If switchable exhaust systems are available, they must be switched to "underwater" at the above points. In particular, in front of the guest harbors and lying areas of the event is the "up and down" and "curves pull" to omit.
- 7) Pulse formations should be avoided during the classification tour. We recommend driving in the wake of the vehicle in front if possible. Special care and respect is required in the canals of Empuriabrava as there are many small rental boats with No License required in the canals.
- 8) Vocational and commercial shipping always takes precedence and must under no circumstances be obstructed or endangered.
- 9) In the case of conspicuous behavior, the corresponding participant can be excluded from the event. Then there is, however, no claim for repayment of the participation fee.
- 10) Each participant has to take care of their own responsibility for sufficient fuel reserves in order to reach the goal. If a participant remains due to lack of fuel, a fine of 250 € is due.
- 11) The organizer reserves the right, for reasons of weather, e.g. Strong rainfall, strong winds to shorten the route, to cancel the event at short notice or to move to an appropriate evasion.
- 12) Anyone who registers and later cannot participate finally has no the right to any reimbursement.
- 13) Each participant has his garbage, e.g. empty cans, bottles, etc., is to dispose of them according to their intended use in the designated places.
- 14) In the harbors, each participant participating in the poker run has the responsibility to inform the crew and their guests about the respective port and dock regulations, which must be complied with.
- 16) Children under 12 years are not allowed in the crew.
- 17) All boat occupants must wear a life jacket during the poker run, which must comply with the required safety regulations of the respective area and have the required certification marks
- 18) It is necessary to respect other boats in the mooring e.g noise (see also 9).
- 19) The instructions of the harbor master, the organizer, the supervisory staff must be followed.
- 20) The handed-in envelopes with the inside playing cards must remain closed when handed in to the jury. Anyone opening an envelope ahead of time will be disqualified and lose the right to win profit. If you lose an envelope, you can buy another card for a penalty of 50 euros. If the participant loses several envelopes he will be disqualified. The sealed envelopes are handed over to the jury for evaluation
- 21) Each participant must provide the organizer with corresponding advertising space on his boat free of charge. Advertising on the boats or in any other form (eg brochures / flyers / videos) is only permitted by the official sponsors of the event and is subject to approval by the organizer.
- 22) It is a privately organized event. The legal process is excluded. Due to the disclaimers, the legal process is limited.
- 23) All participating boats must be accessible during the poker run via a mobile phone. This number must be stored when the paper is picked up. In the event of a technical defect or a disaster of a participating boat, the skipper must notify the Organization team immediately and secure his boat immediately outside the running water. The participant must take care of the salvage and removal.

24) The organizer is not liable for lost items.

25) The organizer has the right to the house and can exercise his right in the case of infringements and exclude participants or direct the place.

Should individual parts of these Terms of Participation which are subject to the contract be invalid or unenforceable or become invalid or unenforceable after signing, the validity of the rest of the agreement shall remain unaffected. The ineffective or impracticable part shall be replaced by a effective and feasible regulation whose effects are closest to the objective pursued by the parties with the ineffective or impracticable part. The above provisions shall as well in the event that the agreement proves to be incomplete.

The contract and the terms of participation are subject to Spanish law.
